



TOWN CLERK'S REPORT
SPECIAL STATE PRIMARY ELECTION

Tuesday, the 8th Day of December, 2009

In accordance with posted Warrants for a Special State Primary, the inhabitants of the Town of Foxborough, qualified to vote in elections met in the gymnasium of the John J. Ahern Middle School, 111 Mechanic Street, in Precincts No. 1, 2, 3, 4, and 5.

The polls opened at 7:00 A.M. with Warden Kathleen M. Brady in charge of all precincts. At 8:00 P.M., the polls were closed, and the ballots were sorted and counted. The number of ballots agreed with the checklists. Of the two thousand five hundred two (2,502) registered voters who cast ballots, one thousand six hundred thirty (1,630) voted on

Democratic Ballots, one (1) voted on the Libertarian Ballot, and eight hundred seventy-one (871) voted on Republican Ballots.

Four hundred thirty-six (436) ballots were cast in Precinct 1; five hundred thirty-five (535) in Precinct 2; five hundred three (503) in Precinct 3; four hundred eighty-four (484) in Precinct 4; and five hundred forty-four (544) in Precinct 5. This was 23.7% of the ten thousand five hundred ninety-four (10,594) inhabitants who were registered to vote at the time of the primary.
