Update on SEMRECC Southeastern Massachusetts Regional 911 (SEMRECC) by Chief Michael Kelleher. Regional Communications center and looking to expand. Keep the economies of scale in line and also expand with more communities.

5. FY25 Budget Review

Discuss & Possible Vote on the FY25 Budget. Follow up from last meeting as we went over the agenda but then we had some questions/concerns to review. AdCom is looking to hear this Boards suggestions/approval. DK reviewed that the local receipt question was answered, and some changes were made post the meeting. Might still be an opportunity for improvement but we don't have all the information. SF - Local receipts seemed to be an area where we could true up that area of the budget. Looked at actuals from 2023 to see what 2024/2025 might look like in terms of local receipts/activity at the stadium. Comfort level on the revenue and expense side of the budget for this upcoming fiscal year. DK – We did pick up some areas of opportunity that we all agreed with. SM – Do we could see the pension obligation to see where we might be trending. LG – would possibly come from the actuary. MA – A study is done every two years to review. No real control on the pension side. Norfolk Country will report what will be coming up and when fully funded, etc. MA – Health and Property/Liability numbers came in which have a savings therefore the revision shows a decrease in free cash.

LG – There is talk about the two fire positions. Will need to see where those savings go. DK – The impact on Norwood Hospital down and how that has been a budget buster and the reasoning behind fire and paramedic increase in teams. PD – In accepting my budget, it would be without the fire position so you would want Chief Kelleher to come back and review. MK – For about \$70K, I think we could bring on one firefighter. I think that makes the most help for the department. LG – Propose taking the next two weeks to review. SM – If we don't have another ambulance, then maybe Chief can explain how that would help with another body when they wouldn't be able to get out for a run.
