2. 7:05pm - Change of Manager Application for Big Night Ventures Foxboro LLC dba The Scorpion Bar & Mexican Cantina at 253 Patriot Place.

Review & Vote on the Change of Manager Application for Big Night Ventures Foxboro LLC dba The Scorpion Bar & Mexican Cantina at 253 Patriot Place from Michael Lisitza to Kelsea Coulter.

Kelsea Coulter, General Manager, Frank Pontoriero—Vice President of Operations for Big Night. General Manager for over 10 years. Discuss & Vote on use of Affordable Housing Trust funds of \$70,000.00 to be committed to Phase II of the Walnut Street Housing Project.

Foxborough Affordable Housing Trust fund was originally funded when State Hospital was being redeveloped. There were supposed to be affordable units there but then the 2008 recession hit. Developer, Doug King and the Planning Board were trying to salvage the project so they worked together to create an affordable housing trust in lieu of the affordable units, bought down these units. In 2015, the trust was just sitting there, \$320,000.00 too much to do nothing, but too little to do anything. Walnut Street Project came along. With MassDevelopment doing some project work in two phases. One stipulation is if you sell the property within X

amount of time, we would owe the money back. We have already paid off our debt for phase one and looking to use the balance of the fund and pay \$12,500 because we have the 50% discount. Committee met on April  $2^{nd}$ , first vote was to take remaining balance and pay down the balance and then take the remaining balance towards the Phase II. There might be interest so I can't say it will be zero. They did vote but we need the Select Board to ratify.

#### 4. 7:20pm - New Street "Eisenhauer Lane" – Ridge Road Subdivision

We work off an approved street listing but its running low. This was also a street that wanted to honor this name so as the road wardens, this needs to be approved by the Board. Michael is our Plumbing Inspector as well as his son is a plumber. This is under review right now and the Planning Board would need to approve after this.

On behalf of my client, FED CAP, Inc., I request that the Foxborough Select Board name a new roadway to be constructed on Ridge Road after Thomas Eisenhauer, who for 28 years was the Foxborough Health Agent and Foxborough Plumbing Inspector. Mr. Eisenhauer moved to Foxborough in 1969 and established his business, T. J. Eisenhauer Plumbing, and raised his three children; Jeff, Michael & Jennifer. He was the Foxborough Board of Health Agent from 1976 to 1988 and was also the Foxborough Plumbing Inspector from 1976 to his retirement in 2004. His son Michael, a Foxborough resident, took over that position in 2004 after his retirement and holds it to this day. His grandson Michael, Jr. is also a plumber and a Foxborough resident.

Neil Kaiser, 11 Ridge Road, Veteran. Think about Veterans that have given their lives as a possible street name. A street corner plaque is just not enough. Gerald Metcalf, Arthur Brown, Gerald Kingsman, Joseph Cook, Mark Grigby, etc. They should be recognized.

Members of the Community have reached out about conservation land down Lakeview that needs updated signage and path is impassable. Limited resources at this time to provide the necessary maintenance at this time but we are thinking of opportunities to the extent we can. There are challenges but a work in progress.

Cultural Council meeting and Foxborough Common Business Collaborative on murals. First mural will be down on the baseball trailer at the Booth Field.

## 8. 7:45pm - Parking Review

Discuss & Vote on Commercial Parking Per Spot Fee for License Renewals for July 1, 2024.

Never want to raise a few without rationale. This fee has not gone up in about 15 years. Evaluation of what the right amount is from a few Town departments. If you take the \$7 and adjust for inflation using the consumer price index, which is the same one we use for the stadium ticket fees, you would get \$10.03 per spot just on inflation alone (43% inflation rate). Assessor reached out to the tax attorney to see how Boston handles parking lots around Fenway. They apply the income approach. They provide the city with the income they receive from these lots. If you capitalize the income, it increases the value of that property. 105 Washington Street, valued a \$2,322,100 which is a tax bill of \$41,774 if you used the income approach, it would be a property value of \$14,210,000 which would produce a tax bill of \$255,638.

Second strategy. Osman provided a recommendation of a tier pricing, closer to stadium would have a higher permit fee but further away would be less. Closer/premium at \$20 per space, \$15 and \$10 as you get further away.

Would suggest a simple approach and there is enough justification for the \$3 increase across the board.

We have reviewed the building fees last year. We were undervalued against surrounding communities. That research was a bit easier. This is a bit difficult as there really is no one else around – no other venue to compare to. Best approach is to using the consumer price index. Now is the time, we have the justification.

Don't want the fee to be for profit. Just want to fee to cover the cost. Simple baseline is what is the cost of time it takes Katie to send out but it's much more than that, police, inspections, etc. Ostman strategy shows the overview. Not proposing to follow that but outlines the work involved. Police and Fire are paid by Kraft. Private lots are not assessed Police and Fire fees.

Can we show that it costs more now? Want to only raise it for the real cost. Not to make money.

With the \$10 the Town would be breaking even. Right now, we are losing money. Regulations say we should be looking at this on a yearly basis. We have to carry special training and equipment that falls on the community. Not sure if we would need it if we didn't have a Stadium. There is an entirely different operation aside from just the details that are already paid. Costs have gone up on the Town side. We are looking to break even and not make money.

Lot owners are not required to provide income statements to see how much they are making. That would be taxed. That would make for property values to increase. If provided net income, tax bill would go up significantly, would be more than the \$3 per space.

Motion to amend the annual per spot fee for commercial parking to \$10 per spot for renewals for July 1, 2024. by L. Gibson, 2<sup>nd</sup> by S. Ferguson.

Mike Stanton, Rt1 Business Owner. Advise is to put the breaks on this increase. Chair of the Water & Sewer Commission that sets rates yearly. Board should be ready to defend this increase. Use an outside firm to help set this rate.

That cost of an outside firm would need to be incorporated into the annual per spot fee.
