5. 7:20pm - Nuisance Dog Hearing - Animal Control Officer Kaycee Bailey

Nuisance dog hearing resulting from an incident that occurred on April 16, 2024, in the Foxborough Boulevard neighborhood, involving 'Mary' a tan Pitbull type female dog – owner – Michael Sitar of 400 Foxborough Boulevard #6202 and 'Gypsy' a black and tan Chihuahua – owner – Kemani Walden of 400 Foxborough Boulevard #4301.

Statutory hearing with a supplementary bylaw in the code of the town of Foxborough. Any complaint by a citizen or ACO, that is filed with the hearing authority which is the Select Board. Parties are open to appear and provide testimony at a public hearing. Need to have one of two key findings, is a nuisance dog or a dangerous dog. Dangerous is a dog that bit a person or another animal or engaged in behavior that the Board deems as a problem to public safety. Nuisance dog is one that bark and/or is annoying but not a threat to public safety. Either one, the Select Board can impose other restrictions that the owner would need to abide by. 1. Restrained, 2. confined to premises, 3. when dog is removed from premises, dog needs to be muzzled and restrained, 4. owner keep insurance in the amount not less than \$100,000 against any claims against acts of the dog, 5. Owner provide information on the dog on a regular basis to the ACO. 6. Dog euthanized. Select Board is the neutral authority which needs to provide a ruling.

The Select Board will hold a Public Hearing on Tuesday, May 7, 2024 beginning at 7:20 P.M. in the Gala Meeting Room, Town Hall, 40 South Street, Foxborough, MA, in accordance with MGL, Chapter 140, Section 157 and Chapter 78 of the Code of the Town of Foxborough to address a complaint filed with the Board relative to an alleged nuisance and/or dangerous dog, resulting from an incident that occurred on April 16, 2024, in the Foxborough Boulevard neighborhood, involving 'Mary' a tan Pitbull type female dog — owner — Michael Sitar of 400 Foxborough Boulevard #6202 and 'Gypsy' a black and tan Chihuahua — owner — Kemani Walden of 400 Foxborough Boulevard #4301. Anyone wishing to he heard on this matter should appear at the time and place designated.

Move to open the public hearing by S. McGowan, 2nd by B. Yukna.

ACO Kaycee Bailey sworn in by Paige Duncan.

Kaycee read the Foxborough Police Department report dated. 4/17/2024. Told both parties that she would be issuing a muzzle order and that a public hearing would take place with both parties allowed to attend and speak. Complaints were submitted from various parties. A review of the complaints that were complied by Kaycee Bailey was reviewed.

Dennis – Both dogs on leash?

Kaycee – That is unclear. Mary was on a leash when arrived and Gypsy had a leash and harness on the table at the vet so one would assume both were on leash.

Stephanie – Was there a puncture near where the vertebra was hit? As the dogs are different sizes.

Kaycee – Is it unclear as to where. On top of the dogs head but beyond that, it is unclear as to what happened.

Kemani Walden sworn in by Paige Duncan.

Kemani Walden, 400 Foxborough Boulevard #4301. Gypsy was a service animal. Never went after another animal. A recount of the event was described.

Michael Sitar sworn in by Paige Duncan.

Mary is listed as a lab mix. Rhodesian ridgeback. Mary is a service dog. Trained to monitor emotions and protection when most venerable. Physically assists in getting up. Has learned directions to get back home and keep safe. Behaviorist background. A recount of the event was described.

Working on stimulation since the incident. I need her for my life as she has changed for the better. This is a civil right for me. Calling her not a service dog is insulting and demeaning. Name calling and rock thrown at our patio door. I have multiple disabilities, when do I count in Foxborough.

Stephanie - Dog owner my entire life. Had a dog that was a barker. You just never know what the dog is going to do. You had mentioned that Mary does not like a lot of dogs, only certain ones, so why did you want them to meet?

Michael – Mary is anxious. My eyes were always on her.

Stephanie – Getting the dogs together was probably not the best idea. Usually, you know when it's time. In retrospect, maybe it was not.

Michael – She did not move to bit she moved to vocalize.

Bill – Is Mary registered in the Town?

Paige – All animals need to be registered within the Town. Service animal or not.

Michael – I did not know you had to register the dog.

Bill – Were you given legal notice to muzzle Mary?

Michael – Yes, but I cannot have her muzzled if I am using her for protection especially from the person that is out to hurt me.

Bill – There was a legal requirement that you did not follow.

Michael – This is effectively violating my civil rights. If I muzzle her, I give up my rights.

Dennis – Has Mary every attached a human.

Michael – No. No one has ever brought it to me.

Dennis – A lot of shaking heads. You are alleging that Mary did not kill the other dog.

Michael – I am not sure of the action of how it happened. Just given the position.

Dennis – Hard to image that Mary did not have any part in killing the other dog.

Michael – That is awful. I am asking for my civil rights for my service dog. I am fine with her being away from other people. There are people that do not like me. I do have a complaint.

Zachary Sitar sworn in my Paige Duncan. 400 Foxborough Boulevard #6202

Retired EMT. Blood on the sidewalk and on Gypsy but not on Mary. Did not notice matted fur near the neck and no blood on the neck.

Kemani – Read the veterinarian report.

Wendy Flanary, 400 Foxborough Boulevard #4107 Seen the dog pulling in on walks, dropping the leash. Since the incident has happened, he is confrontational and nonremorseful. Tenants have seen him without the muzzle, and I have seen him myself. No muzzle publicly.

Stephanie – Legal notice to muzzle Mary. Any reason why we cannot have a muzzle as Mary's rights or his rights as the owner.

Kaycee – As far as ADA compliance, service dog needs to follow the law and can put things in place just like any other animal.

Pat – Primary right of a service dog is being allowed to go into public places where a non-service dog cannot go. This is their legal right. They do need to comply with the law. They are not exempt.

A service dog is not for protection, just the mental health of the individual. For emotional support.

Gretchen Bartol, PO Box 2383 Plainville, MA. Mike exhibits no control while walking Mary. My granddaughter has more control. Mary exhibits obsessive behavior. I was in the dog park once where Mary did charge someone where he was forced to jump the fence while Mike ran after Mary. Notified the Lodge Manager of the incident. There has been tenant harassment towards Mike, however, he puts himself in situations that are aggressive and hostile.

Al Shane, 400 Foxborough Boulevard #7303. I have seen Mary get aggressive. I did witness the incident in the dog park where the neighbor had to jump the fence.

Motion to close the public hearing at 8:32pm by S. McGowan, 2nd by B. Yukna.

Approved. 5-0.

Pat – Board will need to determine between a nuisance dog or dangerous dog.

Stephanie – If we lean towards nuisance, would need some stipulations and what Kaycee's has instituted need to be met. If those are not met, then other actions would follow.

Deb – Would be nervous if the stipulations would not be met by the owner as he feels that they go against his civil rights. Would be OK with the nuisances.

Dennis – Need to be in control when walking any dog. Real responsibility on the owner. I do not feel this I happening. I default to the dangerous dog.

Bill – Concern is the dog shows behavior that is aggressive towards other animals. Based on testimony. I believe if the dog is going to be with other dogs, it should be muzzled. If out for a walk, then not letting her interact with other dogs but that is hard to do. Would really lean towards muzzle. There have been other interactions, so I am thinking dangerous. Maybe nuisances if this was the only interaction.

Mark – I think this rises to the level of dangerous dog. Another dog died. Mary is not registered, and ignorance of the law is not OK. Also, the failure to follow instruction from our Animal Control Officer. Lastly, the dog is in control of herself, but it really is on the owner to be in control.

Pat – Can be nuisance dog with stipulations of a muzzle.

Stephanie – If dangerous, what is the process.

Pat – Need to determine one or the other. Then need to impose the safety action the Select Board deems appropriate.

Bill – Any legal difference between the two. Nuisance and muzzle or dangerous and muzzle.

Pat – Once dangerous, it's like a criminal record that will travel with them. Every Town in MA will have access to that information.

Bill – OK with nuisance but with muzzle. Then will not have these issues.

Mark – If we see no muzzle, what is the recourse?

Kaycee – Once the dog is deemed one or the other, there could be misdemeanors or criminal charges but the courts would handle it from there. Once dangerous, you cannot take it back but you can deem nuisance and if another incident, you can raise to dangerous. Would recommend that the dog be deemed nuisance due to the lack of control of Mary. We can then add stipulations and not just set with the list of options for a dangerous.

Dennis – We have an owner compliance issue.

Motion to deem Mary a nuisance dog by S. McGowan, 2nd by D. Giardino

3 – 0. Mark & Dennis No

Motion where the Select Board has deemed this dog a nuisance dog, that Mary be muzzled when taken out of residence and the owner seek behavior training with a professional trainer by S. McGowan, 2nd B. Yukna.

Bill – Out of the front door is the definition of the residence.

Motion to deem Mary a Nuisance dog by S. McGowan, 2nd by D. Giardino.

Approved. 3-2. Dennis & Mark opposed.

Where the Board has named Mary a nuisance dog, we require Mary be muzzled and leashed anytime she is taken out of the residence. We strongly recommend that the owner of Mary, Michael Sitar, seek behavior training with a professional trainer, by S. McGowan, 2nd by B. Yukna.

Balcony is OK for Mary to be not muzzled. Muzzle is required when she leaves the front door.

Conservation land/sign update Staff met to discuss general maintenance of conservation property including the signs. We came up with a list of 7 signs that are in a state of disrepair and need to be replaced. The material cost for those 7 signs is minimal, ~\$500. Paige and Marie acknowledged there is money in the conservation budget to purchase the material. DPW is willing to do some labor and make the signs, however my highway crew likely won't be able to do that until late fall or the winter. Because we removed the sign from Lakeview and it crumbled as we picked it up, I have enlisted the help of Bill Ivatts and the high school wood shop to make the first sign so DPW can install it. I am going to get the material to the high school by early next week and Bill has said they can get it made prior to the end of the school year. Bill was excited for his students to have the opportunity to get involved with a community project like this.

We also discussed general maintenance. The conservation commission has a list of stewards to be the eyes and ears of the conservation properties. Diana Gray has that current list and can be contacted for anyone looking to volunteer. It's a great way for residents to get involved and

help us care for the 2000+ acres of conservation property. If I can provide any additional information, I'm happy to do so.
